

SKSS 2025 Membership Application



Applicants should read the club rules, bylaws, and safety rules at www.skss.org before submitting this application for membership.

Dues

Adult membership is \$185/year, or \$95/year for "senior" pilots aged 80 or older. There is an early renewal discount: dues are only \$175 (\$85 for seniors) if postmarked before January 1. Dues for a *new* member (not previously a member) who joins on or after July 1st are only \$90.

Junior membership is \$5/year. (A Junior member must be no older than 19 on July 1.) An applicant for Junior membership must include the co-signature of a parent or guardian.

AMA membership requirement

In addition to SKSS membership, you *must* be a current AMA Open or Youth member to fly at the SKSS field. (Membership in the AMA Park Pilot program is not sufficient.)

Park pass requirement

Every SKSS member *must* have an annual State Park vehicle pass issued by DNREC (Delaware Dept of Natural Resources and Environmental Control) in order to fly at the SKSS field. Park passes are sold at any State Park office or online at www.destateparks.com/fees/passes/index.asp.

The club is required to inform White Clay Creek State Park management of all members' park pass numbers. When you purchase an annual park pass for your vehicle, make sure to e-mail its number (including any prefix) to membership@skss.org.

Communications

Day-to-day club communication and notices are handled through an e-mail group hosted on groups.io. When you join SKSS, you will receive an e-mailed invitation to join this group. If you do not receive an invitation, send an e-mail to president@skss.org or membership@skss.org to request one.
